

**TERMS AND CONDITIONS APPLICABLE TO THE
GOODWOOD FESTIVAL OF SPEED 2019 AND GOODWOOD REVIVAL 2019
MASTERCARD PRICELESS EXPERIENCE
PRIZE DRAW**

SECTION 1

The terms and conditions set out in this section apply to all of the prize draws operated by the Goodwood Group. Additional Terms and Conditions applicable to all prize draws are included in Section 1.

1. WHO IS PROMOTING/SPONSORING THIS PRIZE DRAW?

2. CAN I ENTER?

You are eligible to enter this Prize Draw if you meet the following requirements:
